

**Sobriety to Go**

As often happens, we learn the most in AA from listening to our newer members, and my home group recently experienced a new dimension of the Fifth Tradition because of it.

We have a periodic group inventory, every four to six months, so that we can stay healthy as a group. We use the Traditions as well as some of the questions from the "AA Group", pamphlet as our guide. We pick a separate night and spend three or four hours checking our group pulse. At one of these inventory sessions, we had gotten to the Fifth Tradition when a member who had been with us for five months or so spoke up.

"I am confused," he said. "This Tradition says that 'Each group has but one primary purpose--to carry its message to the alcoholic who still suffers.'" He paused a moment, then hesitantly said, "I have been attending this group recently for five months now, and we have never left this room!"

The result of this new member's wisdom and willingness to participate is that our group now sponsors a weekly meeting at a local treatment center. We carry our format and our group's message to them. From this weekly Twelfth Step activity, our group has grown as some of the alcoholics in the treatment center join with us when they leave treatment.

Our group has benefited in several ways other than new members. For a while, we saw an influx of nonalcoholics into the AA groups. Many of these came to us from treatment, having been told to just go to AA by well-meaning professionals who were not really familiar with what AA did and did not do. We have learned that we were at fault when this happened. If we do not show up to explain AA to new people, they will hear about it from people who do not know about AA.

This simple activity of carrying the message out of our meeting room also answered another problem we were having. Those of us who have been blessed by being in AA when there were plenty of "live" Twelfth Step calls talk a lot about them. Our younger members now have an inexhaustible supply of "live" Twelfth Step calls.

By regularly showing up at the treatment center in the spirit of cooperation, we are getting to know the professionals who do deal with problems other than alcohol. When someone shows up at our group who needs help of a different kind from that which we deliver, we can direct them to a person who can help, rather than just throwing them into the winds. This helps us in our effort to stick to our primary purpose, helping alcoholics achieve and maintain sobriety.

By being willing to stick close to our primary purpose, by being willing to actually carry the message physically out of our meeting space, we as a group have made our statement--if you attend a meeting at our group, you will hear the message of Alcoholics Anonymous, and if you watch us, you will see the message of Alcoholics Anonymous in action.

By being a member of a group that participates in the Fifth Tradition as an activity as well as an idea, I find myself more aware of what I was taught from the beginning: The Traditions apply to my personal life as well as to my group. Just as the primary purpose of my AA group is to carry the message, as a member of AA, my primary purpose also is to carry the message. I may not always like the little sacrifices of time and effort, but I am never confused as to what saving my life by God was really all about. The Twelfth Step and the Fifth Tradition make it clear that my sobriety is not only for me--it is for you. Thank God I belong to a group that acts the same way.

1. Do I ever cop out by saying, "I'm not a group, so this or that Tradition doesn't apply to me"?
2. Am I willing to explain firmly to a newcomer the limitations of AA help, even if he gets mad at me for not giving him a loan?
3. Have I today imposed on any AA member for a special favor or consideration simply because I am a fellow alcoholic?
4. Am I willing to twelfth-step the next newcomer without regard to who or what is in it for me?
5. Do I help my group in every way I can to fulfill our primary purpose?
6. Do I remember that AA old-timers, too, can be alcoholics who still suffer? Do I try both to help them and to learn from them?

**TRADITION 5:** "Each group has but one primary purpose - to carry its message to the alcoholic who still suffers."



## ANNUAL ELECTIONS INTERGROUP OFFICERS AND COMMITTEES.

Well, it is that time again, elections for Officers and Committee Chairs. Per our Bylaws elections are held every year during the July Intergroup meeting. The following is a brief description from the South Palm Beach County Intergroup Association Bylaws regarding the process for elections:

**Article VII – Elections and Voting Procedures.** Candidates are nominated from the floor at the regular monthly business meeting in July. Committees are elected every year and Officers are elected every other year (even numbered years). Elections shall be by a simple majority vote of a quorum.

**Article IV – Officers (Executive Committee)** Officers consist of Chairperson, Vice-Chairperson, Secretary and Treasurer. Officer's term of service shall be no more than two (2) consecutive years and is suggested to be five years of continuous sobriety.

**Article V – Executive Committee Chief**

Responsibilities:

Chairperson: To oversee the duties and designated tasks of other officers, committee chairs and Intergroup as a whole. Preside over all meetings; perform such acts and duties as are customary to the office. Appoint committee as necessary. Orient successor.

**Vice-Chairperson:** Primary responsibility for the day-to-day operations of office and staff. Perform duties of the Chairperson in their absence. Perform duties specifically delegated by the Chairperson. Liaison to the Chairperson of committees and help facilitate and coordinate special AA activities. Orient successor.

**Secretary:** Hands on organization of Intergroup business and service. Prepare minutes and deliver to the SCAAN editor by the 15th of the month. Maintain Intergroup office archives of minutes and bylaw amendments. Maintain roster of Officers and Committee Chairs address, phone number and email. Other duties relating to secretarial functions. Orient successor.

**Treasurer:** Maintain Intergroup checking account records. Review with office manager monthly accounting; bank records and taxes and state filings. Give financial reports at the monthly business meeting and newsletter. Orient successor.

**Article VIII – Committees – Standing committees may be established to conduct ongoing business and services of the Intergroup. The committee shall continue so long as it fulfills its designated purpose of Intergroup. There shall be a chairperson of each committee established by a nomination and a vote from the floor or appointed by the Chairperson and/or the Vice Chair when deemed necessary. The position shall be for a period of one year. Elections shall be by a simple majority vote of a quorum. Any committee chair not present at three (3) consecutive regular monthly business and scheduled committee meetings may be automatically replaced, except in the case of extenuating circumstances. Committee chairs and committee members shall have no less than six (6) months of continuous sobriety in order to be eligible to serve. In the case of any committee chairperson using alcohol or mind-altering drugs, they shall be replaced immediately.**

The primary purpose of the South Palm Beach County Intergroup Association is to aid the local AA groups in their common purpose of carrying the message to the alcoholic who still suffers. The following are some of the services Intergroup provides: we maintain the Intergroup Office where members can buy literature, medallions and much more; answer phone calls 24/7; distribute local, District, Area and World Service information, provide meeting lists and monthly newsletters; bring meetings into institutions; provide information to the public; maintain a website and archives.

If you are interested in serving at the Intergroup level please attend the July 30 business meeting where new chair people will be elected for the following committees:

**Archives –** Archivist and committee collect, catalog, and preserve material pertinent to the history of our South Palm Beach County Intergroup. The committee interviews and records the “old timers” recollections and stories and, when possible makes these displays available at local AA events.

**Bridge the Gap –** This is a transitional program directed towards individuals who want to continue their sobriety after leaving a treatment or correctional facility. The Chair coordinates committee members who are “temporary contacts” to accompany new members to AA meetings and answer AA related questions as they transition into the AA community.

**General Service Liaison -** The Liaison is our direct link to the General Service structure of AA. The Liaison attends local District and Area meetings and brings back information and gives report at the monthly Intergroup business meeting.

**Group Information –** Chair and committee visit local AA groups that are not currently represented at the Intergroup monthly business meetings. This committee brings information about Intergroup and how it helps serve the local AA groups; explains the importance of having an Intergroup Representative and collects group contact information and group history.

**Hospitals & Institutions –** Chair coordinates volunteers to carry the AA message to over 45 meetings each month into the South Palm Beach County local facilities. Chairs the monthly committee meeting on the last Wednesday of each month at 6:30 pm at Delray Central House. This committee works closely with Bridge the Gap.

**Public Information –** This committee informs the public about our AA program. The Chair coordinates committee volunteers to supply information to local schools, teachers, business, civic groups, and arrange to staff health fair booths.

**SCAAN Committee –** The Chair and committee assembles edits and prints our monthly newsletter. It publishes a variety of information to educate and inform our local groups, including birthday celebrations, calendar of events, activities, meeting changes, financials, prior meeting minutes, officer report etc.

**Telephone Relay –** Several years ago our Intergroup agreed to cancel the answering service for night and weekend calls and set up a system for local AA members to answer the after-hours calls. After hours are: Monday -Thursday 5pm to 9am; Friday 5pm to Monday 9am. When a volunteer answers the phone they would either answer questions about meeting times and locations or forward call to an available volunteer on the 12-step list so the hand of AA is always available.

**Where and When –** Our local meeting list is printed quarterly. The Chairperson and the office work diligently together to update the current meeting list then proof and print in time to be delivered for the next Intergroup business meeting.

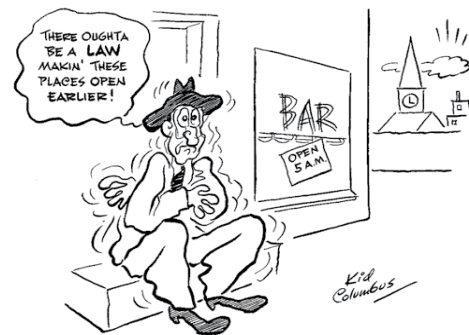
